

# **DATA PRIVACY NOTICE**

## **Life Church Matlock Trustees**

### **1. Your personal data – what is it?**

Personal data relates to a living individual who can be identified from that data. Identification can be by the information alone or in conjunction with any other information in the data controller's possession or likely to come into such possession. The processing of personal data is governed by the General Data Protection Regulation (the "GDPR").

### **2. Who are we?**

Life Church Matlock Trustees is the data controller (nominated contact details below). This means it decides how your personal data is processed and for what purposes.

### **3. How do we process your personal data?**

Life Church Matlock complies with its obligations under the "GDPR" by keeping personal data up to date; by storing and destroying it securely; by not collecting or retaining excessive amounts of data; by protecting personal data from loss, misuse, unauthorised access and disclosure and by ensuring that appropriate technical measures are in place to protect personal data.

We use your personal data for the following purposes: -

- To enable us to provide a voluntary service for the benefit of the public in a particular geographical area as specified in our articles of association;
- To administer partnership records;
- To fundraise and promote the interests of the charity;
- To manage our employees and volunteers;
- To maintain our own accounts and records (including the processing of gift aid applications – see below);
- To inform you of news, events, activities and services running at Life Church Matlock;
- To share appropriate details with the HMRC for the purposes of administering the Gift Aid Scheme which benefits Life Church Matlock by returning tax to the local charity.
- To share appropriate details with the Third Party appointed to undertake an accounts audit on behalf of Life Church Matlock.

### **4. What is the legal basis for processing your personal data?**

- Explicit consent of the data subject so that we can keep you informed about news, events, activities and services and process your gift aid donations and keep you informed about events.
- Processing is necessary for carrying out obligations under employment, social security or social protection law, or a collective agreement.
- The processing relates only to partners or former partners (or those who have regular contact with it in connection with those purposes).
- There is no disclosure to a third party without consent.

### **5. Sharing your personal data.**

Your personal data will be treated as strictly confidential and will only be shared with other partners of the church in order to carry out a service to other church partners or for purposes connected with the church. We will only share your data with third parties with your consent.

**6. How long do we keep your personal data?** We keep data in accordance with our Data Protection and Document Protection Policies.

Specifically, we retain church partnership data while it is still current and for as long as the person remains in partnership with us, and for up to 3 years after; gift aid declarations and associated paperwork for up to 6 years after the calendar year to which they relate.

## **7. Your rights and your personal data**

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data: -

- The right to request a copy of your personal data which Life Church Matlock holds about you;
- The right to request that Life Church Matlock corrects any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary for Life Church Matlock, to retain such data;
- The right to withdraw your consent to the processing at any time
- The right to request that the data controller provide the data subject with his/her personal data and where possible, to transmit that data directly to another data controller, (known as the right to data portability), (where applicable) **[Only applies where the processing is based on consent or is necessary for the performance of a contract with the data subject and in either case the data controller processes the data by automated means].**
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to object to the processing of personal data, (where applicable) **[Only applies where processing is based on legitimate interests (or the performance of a task in the public interest/exercise of official authority); direct marketing and processing for the purposes of scientific/historical research and statistics]**
- The right to lodge a complaint with the Information Commissioners Office.

## **8. Further processing**

If we wish to use your personal data for a new purpose, not covered by this Data Protection Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions. Where and whenever necessary, we will seek your prior consent to the new processing.

## **9. Changes to this privacy notice**

We reserve the right to alter this privacy notice at any time. Alterations and our up-to-date privacy notice will be posted on our website.
